

Ramblings from your Editor

Hi there Circlemashers, another action packed issue of the *Circulator* is here. We have a lot going on this month, so pay attention. Number one on the list: Scale aficionado and all around swell guy, Jim Fruit is joining us on Saturday. Jim has agreed to give us a little presentation on the ins and outs of judging scale contest models. With our attempts to get more folks to attend the annual contest in June, we need to be certain we re running a smooth show for the contestants who are willing to make the trip. More flyers means that more people may be pressed into service to judge scale. It should be very helpful to those involved with judging to get pointers on evaluating competitors aircraft in a fair, consistent manner, so all the scale cats go away with a happy feeling inside at the conclusion of the contest. That way, they might come back next year, and not just to see me. Jim will be starting his presentation at 11:30 in the library meeting room. Please attend this event. It would be a lousy reflection on our club if Jim comes from Illinois to share his experience and we don't show up to hear what he is willing to impart. We will be having a late lunch at the pizza place across Main Street after the meeting if you wish to attend. Jim's lunch is on us, since he is doing us a big favor by making the trip. You are on the hook for your lunch.

On to more scale contest topics. The AMA has decided to make 1/2A scale an official event for 2015. The way I see it, there are ups and downs to this situation. The one big plus here is that it establishes an official set of rules. Provided the AMA rules are used, you should be able to attend almost any scale contest and not need to conform to local rules that may vary from one club to another. It also lends a kind of legitimacy to 1/2A scale that takes it out of the realm of a fun, additional reason to attend a contest (like a balloon bust or something like that) and makes it a more focused undertaking that may appeal to competitors in its own right (more like profile and sport scale). On the bummer end of this, the AMA rules suffer from some ambiguous wording. Let me say here that I don't want to hurt anyone's feelings, but I personally do not see electric motors fitting into the spirit of 1/2A scale. A big part of this event, is getting the little engines to run well enough to complete a flight in anything resembling a realistic manner. Well the AMA rules specify that engines used in 1/2A be between .010 and .061 C. i. displacement. To me, that rules out zero displacement electric motors. Also, this topic has been explored on the stunthangar internet forum, in the scale section, with input from yours truly. This bit is worth looking into if you are interested in the topic. The general consensus among scale guys on the forum is that in spite of some confusing semantics in the rule book, electrics are out for 1/2A scale. Some even went so far as to opine that if they are allowed, participation in your local contest will suffer. Another oddity in the AMA rules is the line size. The AMA rules specify .012 lines for 1/2A scale. What the hell for? A 1/2A profile proto speed model, which may exceed one hundred miles per hour is only required to have .010 lines, but a scale model bumbling along at half that speed, or less, calls for .012 lines? I think this needs a closer look from the rules people. We can discuss this at the meeting, but maybe we should stick to the Brodak rules for this year and hope the AMA works the kinks out of the rules down the road.

Also this month in the newsletter, "Name That Plane" is back. Dave S. had the only correct answer last month and took home a fabulous prize. There is a photo page from last month's meeting featuring projects from two of our members. I have also included a plan robbed from the October 1982 issue of *Model Aviation* for a semi scale FW-190 constructed primarily from corrugated cardboard. Check out the web site. Dave has really done the club a great service in providing this for us.

On a sad note: Circlemasters founder and lifetime member, Bob Ponik was laid to rest in Beaver Dam on Friday, February 20th. Don attended the funeral on behalf of the club.

I will make every effort to be at the meeting promptly at 11:30 AM. I hope you will too.





Dave and Greg showed up for the February meeting with these projects to show us. I hope the rest of you guys are working on something too!




Dave shows us his current Magician and Nobler rebuild projects.




Focke-Wulf FW-190
